5. **PRESIDENT'S AWARD** chosen by BCAB President from individual, Corporate or BC Programs and is presented at the sole discretion of the President.

CRIMESTOPPER OF THE YEAR 2007 (CIVILIAN OR POLICE)

Criteria

This award is for a member of the civilian Board of Directors or RCMP Officer. The criteria and supporting material needed for this award are as follows:

- The program must be a member in good standing of BC Crime Stoppers Advisory Board.
- The individual must be a member of the RCMP or a civilian who is currently on the Board of Directors of the Program which submits the application.
- The events the person is being nominated for must have occurred in the calendar year 2006.
- A letter from the Board Chair or President must be submitted, or, if the Chair or President is the nominee, a letter from the Vice Chair or Vice President must be included. This letter must outline why the person should be considered and relate the leadership, devotion and events during the year. Be specific and exact.
- Letter(s) of support from the police supporting the nomination must be included.
